**RESOLUTION OF THE CLERMONT COUNTY GENERAL HEALTH DISTRICT  
TO REVISE FEES PURSUANT TO OHIO REVISED CODE SECTIONS  
3709.09 AND 3709.21 FOR THE INSPECTION OF MANUFACTURED HOME  
INSTALLATIONS IN MANUFACTURED HOME PARKS IN CLERMONT COUNTY.**

**WHEREAS**, the Board of Health of the Clermont County General Health District has the authority pursuant to Ohio Revised Code Sections 3709.09 and 3709.21 to establish a uniform system of fees for services as specified in Ohio Revised Code Section 4781.04 and Ohio Administrative Section 4781-7-01(G)(1); and

**WHEREAS**, the Board of Health of the Clermont County General Health District is the authorized representative of the Ohio Department of Health to perform manufactured home installation inspections in manufactured home parks in Clermont County per Ohio Administrative Code 4781-7-01 (E)(1); and

**WHEREAS**, Ohio Administrative Code 4781-7-03 (A) specifies that installation of every manufactured home installed in the State of Ohio shall include a minimum of three inspections, known as a “footing inspection”, an “electric inspection”, and a “final inspection; and

**WHEREAS**, the Board of Health of the Clermont County General Health District has previously created an Inspection of Manufactured Home Installation fee which included the cost of performing the minimum three inspections required; and

**WHEREAS**, the Board of Health has now determined that the Manufactured Home Installation fee that has been established effective August 1, 2007 should be stated as each individual inspection fee incorporated into the overall Installation fee.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Health of the Clermont County General Health District, that the following fees be established and adopted to become effective September 1, 2007, as follows:

Manufactured Home Installation Fee:

Footing inspection:	\$ 70.00
Final Inspection:	\$ 70.00
Electric Inspection & Administration fee as of 8/8/2007: (to be performed by the Clermont County Building Department at the fee established by the Clermont County Board of County Commissioners at the time of the inspection)	\$ 60.00

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, by this Board of Health of the Clermont County General Health District, that this revision of the fee be recorded and certified to become a part of the local regulations of the Board of Health of the Clermont County General Health District.

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, by this Board of Health of the Clermont County General Health District, that this regulation be published in one newspaper of general circulation within the Clermont County General Health District once a week for two consecutive weeks, and that the first publication take place no later than ten (10) days prior to the effective date of the revised fee.

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, that this Board of Health of the Clermont County General Health District hereby find by vote of at least three-fourths of its members that this Resolution be read only once and the requirement that it be read on three different days hereby be dispensed with as provided by law.

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, that the Board of Health of the Clermont County General Health District finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal actions, were taken in meetings open to the public, in full compliance with the applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
