RESOLUTION TO ESTABLISH A FEE PURSUANT TO OHIO REVISED CODE SECTIONS 3709.09 AND 3709.21 FOR THE PROVISION OF LEVEL I FOOD SAFETY TRAINING ALSO REFERRED TO AS PERSON-IN-CHARGE FOOD SAFETY TRAINING

WHEREAS, the Board of Health of the Clermont County General Health District has the authority pursuant to Ohio Revised Code Sections 3709.09 and 3709.21 to establish a uniform system of fees for services as specified in Ohio Revised Code Section 3717.09 and Ohio Administrative Code Sections 3701-21-25 and 901:3-4-16; and

WHEREAS, the Ohio Department of Health requires Level I Food Safety Training for a Person In Charge of food service operations and food establishments when new facilities are opened or existing facilities have compliance issues; and

WHEREAS, Board of Health of the Clermont County General Health District feels it is important to be able to offer this training locally; and

WHEREAS, the Board of Health of the Clermont County General Health District has determined that it is necessary to establish a fee in order to cover costs to the program in the provision of this training.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Health of the Clermont County General Health District, that the following fee be established and adopted to become effective **May 1**, 2010, as follows:

Level I Food Safety Training (Person In Charge Training)	\$25/person

NOW, THEREFORE, BE IT FURTHER RESOLVED, by this Board of Health of the Clermont County General Health District, that this establishment of the fee be recorded and certified to become a part of the record of local regulation of the Board of Health of the Clermont County General Health District.

NOW, THEREFORE, BE IT FURTHER RESOLVED, by this Board of Health of the Clermont County General Health District, that this regulation be published in one newspaper of general circulation within the Clermont County General Health District once a week for two consecutive weeks, and that the first publication take place no later that ten (10) days prior to the effective date of the established fee.

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Board of Health of the Clermont County General Health District finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of it's Committees, if any, which resulted in formal actions, were taken in meetings open to the public, in full compliance with the applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
